SUBJECT: Notification of Intent (NOI) to issue an Invitation for International Bidding (IFIB) for the procurement of one (1) ladder fire truck for HQ KFOR fire service located in Pristina, Kosovo.

1. In accordance with the stipulations of the Directive at Reference, Annex C, the following information is provided on an Invitation for International Bidding (IFIB) that this Headquarters has the intention to release:

Title of IFIB : Procurement of one (1) Ladder Fire Truck for HQ KFOR Fire Service. Camp Film City, Pristina, Kosovo.

Requirement : The purpose of this requirement is to supply and deliver one (1) Ladder Fire Truck turntable or with a hydraulic platform with attached ladder in one side, with articulated ladder top section to reach minimum 25m working height and with a rescue cage for rescue and firefighting operations.

Type of Contract : Firm Fixed Price contract.

Estimated Value : Estimated Cost € 950,000.00

Period of Performance : The fire truck should be delivered by 31 December 2026.

Bidding Procedure : Two Sealed Envelopes – lowest price technically compliant bid

Eligibility : Eligible sources are restricted to governmental or commercial entities (1) that originate and are chartered/incorporated within NATO-member

nations, and (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within NATO-member nations that provide the funding for ACO/ACT HQs and/or specific requirement.

Joint Venture and or any type of temporary grouping of companies will not be considered eligible to participate in this bidding process.

Only bidders that hold a current and valid Data Universal Numbering System (DUNS) number and that the related Dun & Bradstreet (D&B) report or equivalent document does not highlight significant risk of business failure will be considered eligible for contract award.

Delivery location (s) : KFOR HQ, CFC, Pristina, Kosovo.

Partial Bidding : Is Not Authorized.
